1. DRAFT INTEGRATED DEVELOPMENT PLANNING (IDP) REVIEW REPORT: 2009/2010

The Committee expressed the view that it should be indicated in the Executive Summary of the Report that the data reflected in the report were that of the last census. The possibility of conducting a municipal census every two years, either by Drakenstein or as part of the Cape Winelands District Municipality, should be investigated to ensure that data used for the purpose of integrated development planning are as relevant as possible. It was indicated that such discussions were already taking place amongst officials within the District and that a report in that regard would be submitted. The necessary steps should also be taken to ensure the integrity of such data. It was further agreed that the IDP and Budget Roadshow should be limited to one public meeting for Paarl, Wellington, Mbekweni, Saron and Gouda as well as one public meeting for the rural wards.
