The Executive Mayor made the following announcements:

1. Drakenstein Municipality's tap water is safe to be used and not needed to be boiled;
2. A letter was submitted to NERSA objecting to the proposed electricity tariff increase of 20.5% submitted by Eskom. Subsequently NERSA approved a much lower tariff increase of 9.5%;
3. Drakenstein Municipality has embarked on a drive to generate sufficient renewable energy to become less dependent on Eskom. For that purpose the Municipality is working with the Western Cape Government to investigate uninterrupted power supply in an affordable way;
4. Media reports that Drakenstein Municipality no longer wants to invest in, or support tourism is untrue and that the Municipality will focus specifically on economic development, destination marketing and on promoting Drakenstein as a sport tourism and adventure sport destination. For that purpose the Municipality will work together with the DLTA and with other partners such as Wesgro and SA Tourism; and
5. Ward committee elections have been finalised and expressed a word of appreciation to the City Manager and the staff that ensured the successful completion of the process.

The proposer of the motion, Cllr A Fourie explained the gist of the motion as contained in the agenda.

He indicated that the motion was essentially about restoring and enhancing the potential of the Berg River bank as a tranquil space for residents and respecting the privacy of the nearby residents, the lack of political will to deal with the matter by the political leadership, the abdication of that responsibility to the administration as well as to get legal certainty as to whether swimming is allowed in the Berg River, or not.

Several responses were then allowed by the Speaker inter alia by the Executive Mayor who indicated that measures put in place has had the desired effect and order was restored to the river banks and that it must be accepted that the river belongs to all the inhabitants of Drakenstein.

The motion was thereafter put to the vote and was defeated by 56 votes to 3 votes.
