The Freedom Front Plus raised concerns with regards to the ward elections in ward 17 and 18 as they were of the view that a candidate was disadvantaged as the name of the candidate was initially omitted on the ballot paper. Although the name of a candidate in Ward 17 was later added, the name did not appear on all the ballot papers. In addition further concern was expressed with regard to Municipal transport being provided to

community members and the subsequent lobbying that took place at the election venue which seem to benefit only one particular political party. The Speaker responded that all reasonable measures were taken to ensure the credibility of the election process. Those provided with municipal transport were having health challenges and were not necessarily supporting a specific political party.

The recommendations were put to the vote and carried by 46 votes to 0 votes, with 16 abstentions.

RESOLVED that

1. The Ward Committee Election results (attached as Annexure A to the departmental report) for Wards 1 to 33 which details the names and surnames of Ward Committee members who were either uncontested or elected (excluding persons who are not eligible and highlighted in Annexure A), be approved;
2. It be noted that the candidates who received the top 10 number of votes in each ward will serve as ward committee members unless they are not eligible, in which case the candidate with the next highest number of votes will be declared elected, subject to their eligibility; and
3. It be noted that the names and surnames of elected Ward Committee members be made public.
