

The Deputy Executive Mayor responded to questions raised by the EFF on roll-over capital funds by indicating that certain projects were already committed but not completed, and therefore had to roll over. Delays were caused by the Covid-19 lockdown period.

5. The operating revenue of R2,693,203,372 (capital grants included) approved by Council in May 2020 be increased with R14,662,299 to R2,707,865,671 for the 2020/2021 financial year;
6. The operating expenditure of R2,609,018,595 approved by Council in May 2020 be increased with R1,187,000 to R2,610,205,595 for the 2020/2021 financial year; and


