 - 1.1 The subject property is not needed to provide the minimum level of basic municipal services; and
 - 1.2 The fair market value of the asset and the economic and community value to be received in exchange for the asset has been considered.

2. In terms of Section 14 of the Municipal Finance Management Act No. 56 of 2003 *final approval* be granted for the alienation of a portion of Erf 1799 (Public Place), measuring approximately 898m² in extent, at a market related selling price of R760,000.00 (VAT excl.), to the adjacent landowner of Erf 9173 Wellington (Mr Ahmed), subject to the standard conditions of sale and the following further conditions:
 - 2.1 The subject property be closed, rezoned, subdivided and consolidated with Erf 9173 Wellington. These land use applications must be undertaken by and at the cost of the applicant;
 - 2.2 The transaction is subject to all technical conditions imposed by the various technical departments; and
 - 2.3 Approximately 550m² in extent will be developed as private parking and the remaining portion of approximately 348m² in extent must be developed as public parking.

3. The Department: Engineering Services investigate the changing of the one way Regent Street currently being a one-way street to a two-way street for urgent implementation;

The subject property is a viable portion of land and in terms of Paragraph 13 of the Asset Transfer Policy it can be alienated directly to the adjacent landowner, where such landowner requires the subject property for the extension of its existing business and such extension will be in public interest.
