

## **EPWP WASTE MANAGEMENT YOUTH JOBSEEKERS.**

Drakenstein Municipality invites qualifying youth to apply for training opportunities within the Solid Waste Management department at the municipality.

### **A. EPWP STUDENT TRAINING OPPORTUNITIES.**

Students (youth) with training in (i) Waste Management (ii) Environmental Management (iii) Building / Civil Technicians and (v) Solid Waste Management are being offered the opportunity to receive in service training in the waste management field.

These opportunities relate to the supervision of illegal dumping cleaning teams and organizing the weekly response to the situation on the ground.

### **B. EPWP YOUTH OPERATOR TRAINING OPPORTUNITIES.**

Youth with skills and training in operating construction equipment (i) digger loaders, (ii) front-end loaders or (iii) 10m<sup>3</sup> tipper trucks.

### **C. GENERAL SELECTION REQUIREMENTS FOR THE ABOVE OPPORTUNITIES.**

- South African citizen.
- Grade 12
- Below 30 years of age.
- Valid Code B driver's license.
- Resident within Drakenstein Municipal area.
- Fluent in two of the three official languages of the Western Cape.
- Unemployed.
- Access to transport or willing to use public transport to reach venue.

### **D. ADDITIONAL PREFERENCE CONSIDERATIONS**

- For Digger Loader training it is preferred that the applicant has a valid C1 license.
- For tipper truck training it is preferred that the applicant has a valid EC driver's license.
- Valid PrDp.
- Minimum Grade 10 education.

**ALL APPLICANTS WILL NEED TO PASS A PRACTICAL SKILLS TEST IN ORDER TO QUALIFY.**

**Learners will be rotated between Drakenstein Municipality, their place of learning and private sector training facilities as part of the development program.**

## **E. EPWP STIPEND**

Learners will be paid the EPWP supervisor wage of R180 per day.

Note: Proof of citizenship, residence, driver's license, and educational results are required for assessment.

(Clear certified copies of ID Document, Proof of address and Certified Educational Results must be attached for applications to be considered.)
