The Speaker opened the item for debate after which the proposer of the motion, Councillor A M Richards of the ANC, indicated that the motion was clear and has nothing to add. He however indicated that he wishes to present the Speaker with a document which contained a request from a number of councillors for a secret ballot on the motion.

The Speaker indicated that the matter would be dealt with after the debate on the motion. Councillor A Fourie of the Freedom Front Plus, one of the secondi of the motion, also indicated that the motion was clear in that it calls for the removal of the Executive Mayor as several councillors lost confidence in his ability to lead the Council.

Councillor S Korabie of the DA argued that the motion lacked substance and should therefore not be entertained. The Speaker ruled that the motion complied with all legislative requirements and would therefore be considered.

The Speaker then indicated that the document submitted by Councillor A M Richards appeared to be signed by a majority of councillors present in the meeting and called a recess of 15 minutes at 11:40 in order for him to verify the signatures against the attendance register. He indicated that he would be assisted in that regard by the Administration. At the same time the DA also called for a recess.

After the recess the DA requested access to the document, which was denied by the Speaker.

The Speaker indicated that he was satisfied that the document indeed contained the signatures of a majority of councillors present in the meeting and he would now have to apply his discretion on whether to grant the request for a secret ballot, or not. The Speaker explained at length the factors he had to consider in applying his discretion and ruled, after taking all the factors into consideration, that he is satisfied that there is a case for a secret ballot. He subsequently ruled that the motion be voted on in secret.

After the ballot was prepared and secret ballot conducted, 34 councillors to 26 councillors with 2 councillors abstaining voted in favour of the motion for the removal of the Executive Mayor, Alderman C J Poole.

On a question raised, the Speaker indicated that the Deputy Executive Mayor will act as Mayor until a new Mayor is elected and that the Mayoral Committee was also disbanded with immediate effect.


