- 1.11 Municipal services must be identified on site by the Engineering Services Department before any temporary structures are to be erected and may not be erected without approved building plans;
- 1.12 Any damage caused to municipal services will be repaired at the cost of the lessees; and
- 1.13 All administrative, legal and technical requirements be adhered to.


