

- 2. In terms of paragraph 13 of the Asset Transfer Policy, the property be leased by way of direct negotiation as the transaction entails a formalisation of a lease agreement for office space that is required by a Chapter 9 (Constitution of RSA) institution for official purposes; and
- 3. Approval for the deviation from paragraph 13.2.1 of the Asset Transfer Policy of 2021 allowing the Municipality to enter into the lease agreement with the lessee without counter proposals or offers being called for and obtaining objections or
