- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1. This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2. Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

SCOPE OF WORKS

1. Background

Drakenstein Municipality has a climate partnership with the City of Neumarkt. This climate partnership provides the municipality with an opportunity to access various funding programmes. One such programme is the NAKOPA (Partnership for Sustainable Local Development) programme. The main objectives of this programme is to make the river ecosystem more resilient to the effects of climate change and encourage public participation from the community throughout the project. There is currently a service provider appointed to design and construct a river walkway within the project area.

The scope of the works comprises of a service provider to undertake ecological rehabilitation, of the riparian area, for a part of the Berg River in Paarl (between the Market Street bridge and the Lang Street bridge).

The contract will comprise of the following components:

- a. The appointment of a professional service provider to conduct active rehabilitation (sourcing, propagation and planting of indigenous plant species) of riparian sites along the Berg River (between the Market Street bridge and the Lang Street bridge);
- b. Identification of suitable areas for ecological rehabilitation along the project area;
- c. Identification of suitable vegetation to be planted in the riparian area of the Berg River;
- d. Procurement of indigenous riparian seedlings and cuttings to be done by service provider and quantity of plants procured to be reported;
- e. Planting of indigenous seedlings and cuttings within the identified areas suitable for rehabilitation;
- f. A map detailing the areas suitable for rehabilitation;
- g. Demonstration of compliance with the Occupational Health and Safety Act, including considerations for water safety;
- h. Design an irrigation plan for the rehabilitated areas; and
- i. A report of the number of seedlings planted and the determination of survival of planted vegetation recorded 6 months after planting.

3. Materials and Workmanship

The report will provide information on the activities undertaken by the contractor for the respective month detailing the following information for the rehabilitation sites:
- Site condition: how is the rehabilitation site fairing, noting challenges and successes, in terms of establishment of species planted and secondary invasions and management thereof;
- Site activity: the work undertaken on the site in terms of maintenance of sites (i.e. weeding, planting, checking irrigation etc.);
- Number of plants: document the number and type of species of plants delivered to site for a given month;
- Number of person days: document the number of labour person-days based on the activity undertaken;
 - Describe key actions planned for the following month and delivery/progress on such actions from the previous months reporting.
- Incorporate photographs and/or video of sites and plants to showcase work achieved and/or challenges experienced.
- Provide information, status and progress related to risk and risk management protocol for the project implementation generally.

6. Site inspections
