- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

# 2. Standards and Specifications

All relevant specification standards and legislation will apply where applicable.

- 2.1. SABS 1200 will be used as standard specifications
- 2.2. All projects will fall under the General Conditions of Contract 2015

- 2.3. The construction areas will be pointed out by the Engineer or Project Manager as and when required
- 2.4. The contractor will measure and verify quantities of proposed work package
- 2.5. An approved safety plan to be on-site at all times as per OHS Act No. 85 of 1993

## 3. Materials and Workmanship

Workmanship shall be of the highest quality and any inferior work will be rejected. Any rejected work shall be made good at the contractor's own cost.

- 3.1. All materials to be approved by the Engineer or Project Manager
- 3.2. All work to carry a defects and liability period of 12 months after completion of works

Wayleaves will be the responsibility of the contractor, who will timeously arrange with the relevant municipal departments or service providers to point out various underground services.

 The firebreaks must be cleared by brushcutting all grasses, cutting shrubs, pruning indigenous trees (larger than 20cm diameter, up to 2m height) and cutting and removing smaller trees (less than
 Page 26 of 41 20cm diameter). As well as the cutting and treatment of invasive alien vegetation, which may occur within the firebreak, according to the schedule of methodologies and prescribed herbicides (as prescribed by the Working for Water methodologies).

- A Registered Pest control officer must oversee the contract work and application of herbicides.
   Training certificates and registration documents must be up to date and submitter with the quotation.
- Proof of equipment and qualifications must be attached to the quote.
- All material (biomass and garden waste) must be removed from the firebreak, so that the area is
  clear of all plant material. Material may be carried up further into the adjacent dense vegetation in
  the mountain above the firebreak away from residential properties, as indicated per site visit.
- Should garden refuse be in the firebreak at any point from the day of the site visit until completion of the firebreak, it would be expected of the contractor to remove it outside the firebreak, in areas identified during site visit. A contingency must be included in price quote for this.
- All other general rubbish or garden refuse must also be removed, including glass, plastics, metals
  and any other refuse not indigenous to the mountain. The contractor must ensure sufficient refuse
  bags on site at all times.
- The Contractor must have a minimum of 5 chainsaws and 5 brush cutters and so many trained operators. Proof of equipment AND qualifications must be attached to quote. All training certificates must be valid and certified.
- The Contractor must have a minimum of 5 years' experience in the design and preparation of
  effective firebreaks in fynbos and mountain areas. 2 Contactable references should be supplied of
  relevant work done.
- It would be expected of the contractor to have firefighting equipment on site during firebreak preparation operations, e.g. fire beaters, fire extinguishers, water supply equipment as work will be carried out in high fire season and the work itself poses a hire fire-risk.
- The Contracting team must have knowledge, experience and training in firefighting operations. 2 Contactable references should be supplied of previous firefighting work and experience. Training certificates should be supplied. All training certificates must be valid and certified.
- The contractor and his/her contractor team must comply with the Rules & Regulations of the Paarl Mountain Nature Reserve (attached).
- It would be a requirement of the contracting team to work in an area where accessibility is difficult and against steep slopes, behind residential houses and bordering the urban edge of Paarl.
