## **APPLICATION FOR CONSENT USE: ENVIRONMENTAL HEALTH INSPECTION REPORT, ERF 15894, PAARL**

An inspection, under the Cape Winelands District Municipality Health By-Laws (Feb 2010), was conducted on the above-mentioned premises.

The following was found:

### **A. BUILDING**

- I. The structural condition of the building is reasonably acceptable. There are two (2) classes provided for age 0 - 1 years old which accommodates six (6) children and age 2 – 5 years old which accommodates twelve (12) children.

### **B. KITCHEN**

- I. The premises is equipped with a kitchen which prepares meals for the learners. The kitchen has a Certificate of Acceptability.

### **C. SANITARY FACILITIES**

- I. 1 toilet is provided for the learners and potty toilets for the 0-2 years age group.
