

- 1.2 The purchaser will be responsible for all costs related to the transaction and the development;
- 1.3 The proposed transaction be advertised in the local press for objections, comments or counter offers;
- 1.4 The municipality must at all times have access to the subject property for maintenance and upgrading of services on the site;
- 1.5 The proposed development of the subject property must be completed within a period of 36 months from date of registration of transfer and is subjected to the development timeframes as set out in the standard conditions of sale, attached as Annexure C to the departmental report, paragraphs 1.4, 1.12 and 3.2;
- 1.6 Any re-development and/or construction work undertaken on the subject property must comply with the relevant statutory requirements and subject to obtaining building plan approvals; and
- 1.7 The purchaser must note the heritage status at the property and the restrictions it poses.
