TENDER DESCRIPTION: THE PROVISION OF GUARDING SERVICES, ARMED RESPONSE SERVICES AND SUPPLY AND INSTALLATION OF CCTV CAMERAS, ALARMS AND BEAMS FOR A 5 YEAR PERIOD

Notice is hereby given in terms of section 33 of the Local Government: Municipal Finance Management Act, No. 56 of 2003 that Drakenstein Municipality ("the Municipality") intends to enter into a contract for the provision of guarding services, armed response services and supply and installation of CCTV cameras, alarms and beams for a 5-year period. The contract will impose financial obligations on the Municipality for a period longer than three (3) years covered in the annual budget for the 2024/2025 financial year.
