1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.



## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

1. This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
2. Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
3. Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
  - a. take all reasonable steps to prevent such abuse;
  - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and

## Specification: Rectangular Precast/Cast-in-Place Concrete Benches & Tables

**Purpose:** Provide standardized, durable, accessible concrete benches and matching rectangular tables for use at the Saronresort. Each bench shall accommodate 3 average adults.

---

### 1. Summary dimensions (typical — for 3-person bench)

- **Bench length (nominal):** 1,650 mm (1.65 m)
- **Seat width (depth):** 450 mm
- **Seat height above finished ground:** 450 mm
- **Seat thickness:** 60 mm (solid slab top) or 80–100 mm if cantilevered ends occur
- **Overall bench footprint (with base supports):** length 1,650 mm × depth 500–600 mm
- **Table (rectangular) typical size:** 1,500 mm long × 800 mm wide × 750 mm high (tabletop thickness 60–80 mm)

Rationale: 1,650 mm gives ~550 mm per person (comfortable). Seat height 450 mm is commonly used for outdoor seating and aligns with accessibility guidance ranges.

---

### 2. Design & structural requirements

- **Design standard:** Concrete materials, workmanship, testing and tolerances shall comply with the latest SANS 1200 series provisions for structural concrete works (materials, mixing, placing, compaction, curing and tolerances). Include SANS 1200-GB guidance for ordinary reinforced concrete works.
  - **Concrete strength:** Minimum characteristic compressive strength at 28 days: **C30/37 (30 MPa)** for cast-in-place and precast bench/table units. Use higher strength (C35/45) where units are slender or carry concentrated loads.
  - **Reinforcement:** Grade and detail reinforcement to resist bending and local loading — typically **Y12 or Y16 bars** in top and bottom layers as required by structural calculation; include shear links where cantilevered. Provide stainless steel or epoxy-coated reinforcement if near corrosive environments (sea spray).
  - **Design load:** Design seating to safely carry a **concentrated load of 1.5 kN per seat** and an overall uniformly distributed load of **3 kN/m<sup>2</sup>** on the seat surface (or structural engineer's calculation). Provide factor of safety per SANS 1200 guidance.
  - **Anchorage:** Where benches are to be fixed, provide stainless steel lifting/anchor boxes cast in with M12–M16 anchor sleeves or chemical anchor sockets sized for final fixings.

- **Cement:** SANS-compliant Portland cement (or blend) meeting SANS 50197 / SANS 50197-equivalent requirements.
  - **Aggregates:** Clean, well-graded coarse and fine aggregates meeting SANS gradation and quality limits. Maximum aggregate size 10–14 mm for smooth finish on visible surfaces.
  - **Admixtures:** Use approved water-reducing or air-entraining admixtures as required for workability and durability.
  - **Water/cement ratio:** Limit to achieve specified strength — typical  $w/c \leq 0.50$  (adjust to site conditions and admixtures).
  - **Surface finish:** Exposed faces to be power-trowelled and sealed, or bush-hammered/exposed-aggregate per finish schedule.

#### 4. Durability & environmental considerations

- **Exposure class:** Specify exposure class (e.g., marine, moderate) and select concrete cover accordingly (minimum cover for reinforcement per SANS 1200; increase for marine/external chloride exposure).

  - **Clear approach:** Minimum clear ground space for approach and circulation to comply with SANS 10400-S and local building controls (provide one clear space adjacent to bench 800 mm × 1,200 mm where required).



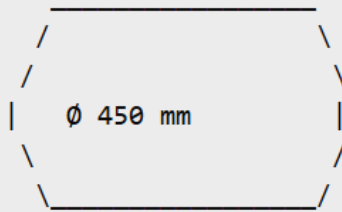

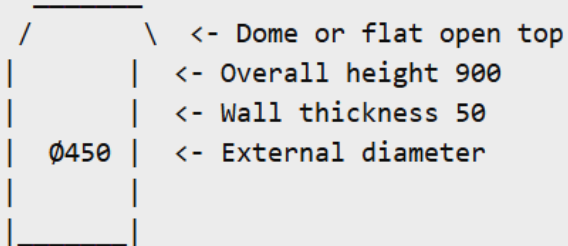
